1. **PRODUCT:** WICKES WOODCARE Fungicidal Wash **PAGE:** 1 of 5  
**REVISION:** 5 **DATE:** 1.11.07  
**USE:** A ready for use water-borne sterilisation fluid to prevent and inhibit the growth of mould and mildew.  
For use only as a surface biocide. Application by brush, cloth or sponge.
2. **HAZARDS IDENTIFICATION**  
The product is cleared under the U.K. Government's 'The Control of Pesticides Regulations 1986' for use as directed. HSE No 6039. Refer to sections 15 and 16 for full classification and statutory conditions relating to use. The product is not classified as dangerous according to the CHIP Regulations. See also section 11.
3. **COMPOSITION/INFORMATION ON INGREDIENTS**

4. **FIRST AID MEASURES**  
**General:** In all cases of doubt or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person.  
**Inhalation:** Remove to fresh air, keep patient warm and at rest. If breathing has stopped, administer artificial respiration. Give nothing by mouth. If unconscious, place in the recovery position and seek medical advice.  
**Skin Contact:** Remove contaminated clothing. Wash skin thoroughly with plenty of water.  
**Eye Contact:** Remove contact lenses. Irrigate copiously with clean, fresh water, holding eyelids apart, and seek medical advice.  
**Ingestion:** If accidentally swallowed obtain immediate medical attention. Keep at rest. DO NOT induce vomiting.
5. **FIRE FIGHTING MEASURES**  
The liquid product is 'non-flammable'.  
**Extinguishing Media:**  
Recommended: alcohol resistant foam, CO<sub>2</sub>, powder, water spray/mist  
Not to be used: water jet  
**Recommendations:** Fire will produce dense black smoke containing hazardous products of combustion (see section 10). Exposure to decomposition products may be a hazard to health. Appropriate self contained breathing apparatus may be required. Cool closed containers exposed to fire with water spray. Do not allow run off from fire fighting to enter drains or water courses.
6. **ACCIDENTAL RELEASE MEASURES**  
Avoid breathing vapours. Refer to protective measures listed in sections 7 and 8. Contain and collect spillages with non-combustible absorbent materials e.g. sand, earth, vermiculite, diatomaceous earth and place in a suitable container for disposal in accordance with the waste regulations (see section 13). Do not allow to enter drains or water courses. Clean with water. If the product enters drains or sewers, immediately contact the local water company; in case of contamination of streams, rivers or lakes, the relevant environment agency.
7. **HANDLING AND STORAGE**  
**HANDLING:** Avoid contact with skin and eyes. Smoking, eating and drinking should be prohibited in storage and use areas. For Occupational Exposure Controls measures see Section 8. Keep the container tightly closed.
- The Manual Handling Operations Regulations** may apply to the handling of containers/packages of the product. To assist employers the following method of calculating the weight of any pack size is given. Take the pack size volume in litres and multiply this figure by the specific gravity value given in section 9. This will give the net weight of the product in kilograms. Allowance will then have to be made for the immediate packaging to give an approximate gross weight.

**STORAGE:**

Observe label precautions – Store between 5°C and 25°C in a dry, well ventilated place away from sources of heat, ignition and direct sunlight. Prevent unauthorized access. No smoking. Keep out of the reach of children. Store separately from oxidizing agents and strongly alkaline and strongly acidic materials. Containers which are opened should be properly resealed and kept upright to prevent leakage.

**8. EXPOSURE CONTROLS/PERSONAL PROTECTION**

**EXPOSURE CONTROLS:** Provide adequate ventilation. Where reasonably practicable this should be achieved by the use of local exhaust ventilation and good general extraction. If these are not sufficient to maintain concentrations of particulates and/or solvent vapours below the Exposure Limit Values, suitable respiratory protective equipment must be worn (see ‘Occupational Exposure Controls’ below).

**OCCUPATIONAL EXPOSURE CONTROLS:** All Personal Protective Equipment, including Respiratory Protective Equipment, used to control exposure to hazardous substances must be selected to meet the requirements of the COSHH Regulations.

**RESPIRATORY PROTECTION:** If exposure to hazardous substances identified above cannot be controlled by the provision of local exhaust ventilation and good general extraction e.g. work in enclosed areas, suitable respiratory protective equipment should be worn.

**HAND PROTECTION:** When skin exposure may occur, advice should be sought from glove suppliers on appropriate types and usage times for this product. The instructions and information provided by the glove supplier on use, storage, maintenance and replacement must be followed. Barrier creams may help to protect exposed areas of skin but are not substitutes for full physical protection. They should not be applied once exposure has occurred.

**EYE PROTECTION:** Eye protection designed to protect against liquid splashes should be worn.

**SKIN PROTECTION:** Cotton or cotton/synthetic overalls or coveralls are normally suitable. **10. STABILITY AND REACTIVITY**

Stable under the recommended storage and handling conditions (see section 7). In a fire, hazardous decomposition products such as smoke, carbon dioxide, carbon monoxide and oxides of nitrogen may be produced. Keep away from Oxidizing agents and strongly alkaline and strongly acidic materials to prevent the possibility of an exothermic reaction.

**11. TOXICOLOGICAL INFORMATION**

There is no data available on the product itself. The product has been assessed following the conventional method in CHIP and is classified for toxicological hazards accordingly. This takes into account, where known, delayed and immediate effects and chronic effects of components from short-term and long-term exposure by oral, inhalation and dermal routes of exposure and eye contact. See sections 2 and 15 for details of the resulting hazard classification. Splashes in the eye may cause irritation and reversible local damage. Repeated or prolonged contact may lead to removal of natural fats from the skin resulting in non allergic contact dermatitis.

## 12. ECOLOGICAL INFORMATION

There is no data available on the product itself. The product should not be allowed to enter drains or water courses or be deposited where it can affect ground or surface waters. The product has been assessed following the conventional method in CHIP and is not classified as dangerous for the environment, but contains substances so classified. See section 3 for details. .
